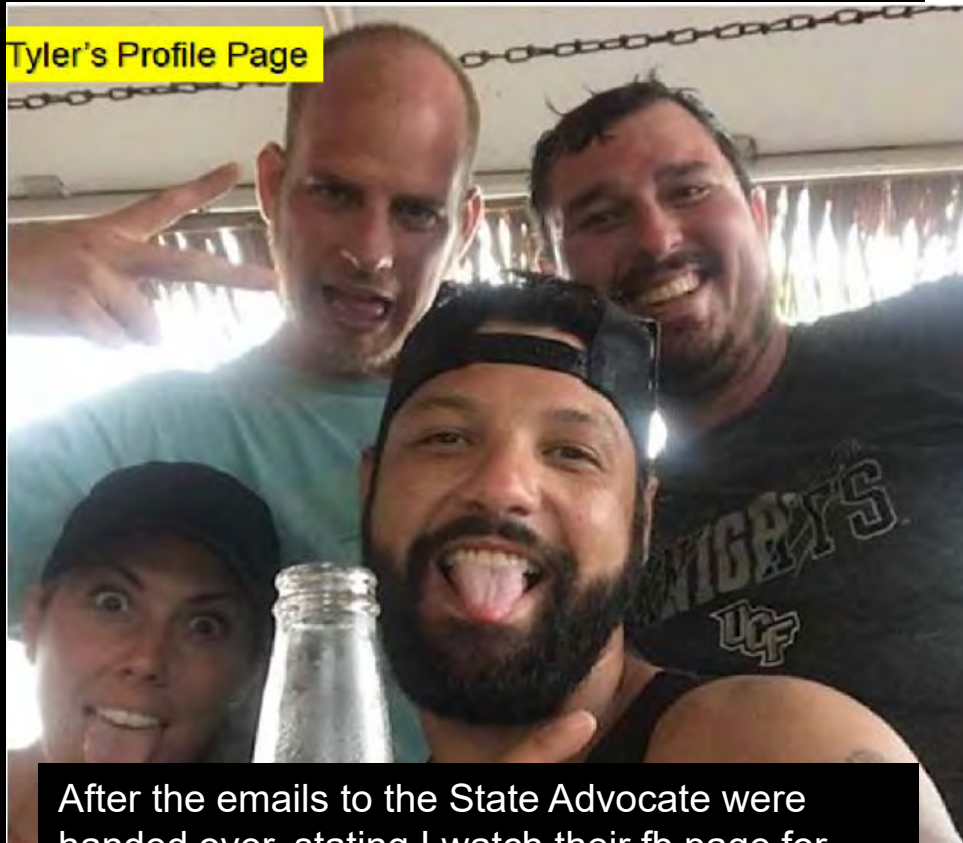

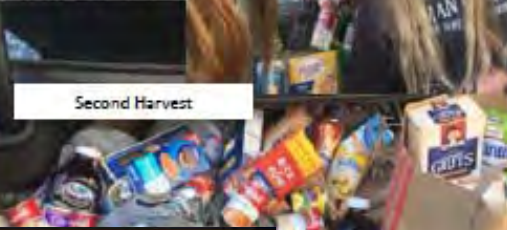

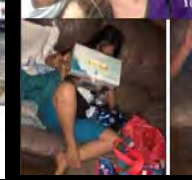

Dear Assistant District Attorney of the Ninth Judicial Circuit,

I have known Janet Kotz in a working capacity and as a friend for over eight years. My position with Coleman Aerospace as Director and FSO for the Defense Security Service and as a Missile Defense Agency Contractor, has given me the authority to know Janet more than most co-workers would know her. In her twenty-five years of service, Janet has never failed a drug test and has passed two thorough FBI background checks. Janet holds a "Secret" level security clearance with the Department of Defense. Employees with this level of clearance undergo a plethora of paperwork asking highly personal questions, background checks, interim training, and annual refresher classes. Janet is our Senior Communications Analyst. This position requires a lot of trust considering her media output and proposal work is representing the entire company.

As the Director of Security and Support Services, Janet reported directly to me in her role as the Manager of Multimedia Communications. She showed dedication to her job and her employees. When the company required bids for government defense programs, she managed a crew to put together government proposals and she never missed a deadline. Janet worked up to ninety-hour workweeks without fault, in order to meet strict deadlines. Janet earned respect from her team as well as demonstrating a healthy lifestyle in order to be able to withstand these long hours. During proposal processes, Janet would be the first to come in and the last to leave in order to give the most time off allowed to the members of her team. This showed me her appreciation and care for others. I have never had a complaint regarding Janet's integrity, loyalty, or ability in the workplace. I personally trust her judgement and honesty as well. Prior to my coming to Coleman Aerospace, Janet was instrumental in revealing an Israeli spy. Janet did not receive recognition for this effort for over ten years due to the sensitivity of the Facility Security Officer at that time. Janet never told anyone about this until it came to our attention ten years later in an announcement made by this former Facility Security Officer in one of the Annual Security training classes. Janet has also lost two friends because of terrorist incidents. These things have proven to me her patriotism, humility and trustworthiness to a very high level.

I would also like to let you know what a strong woman Janet is. Not only did she surpass the injuries and losses from an abusive husband of almost ten years, the losses, hurdles, and burdens in her life seem to be the norm. From the time that I have known her, Janet has undergone numerous surgeries to repair injuries sustained from her ex-husband. Within a span of three years, Janet lost her work mentor, her pastor, a dear friend, and ultimately she lost her mother. As we were all aware of her work mentor and her mother dying, not many people knew about her friend and her pastor dying. Janet always tries to laugh or smile, leaving most people thinking she does not have a problem in the world. Janet just doesn't wear her problems on her sleeve by complaining to everyone about them. After finding out about this heinous attack, so soon after losing her mother, we offered her leave with pay in order take time off from work to heal. Janet declined the need for time off and has continued to work full time in addition to some overtime, to ensure her responsibilities are fulfilled.

In summary, I would like to say that I have a very high regard for Janet Kotz personally and I have a strong respect for her character and her care for others professionally. Janet is trustworthy, honest, and demonstrates a tremendous conviction to her religion, family and her job. I wish all employees had her integrity.



To Whom It May Concern,

I have known Janet Kotz for 12 years. We both worked at a small company called Coleman Aerospace which was a defense contractor supporting missile defense testing. During part of that time, I was Janet's boss. She was always a dedicated worker putting in extra hours whenever needed. The company was in trouble for a few years before I took over. 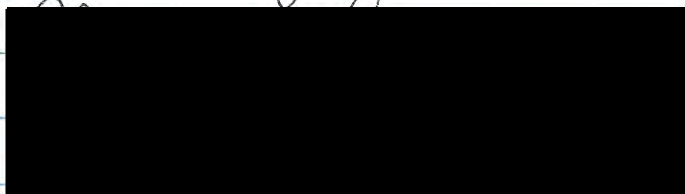
