Florida Attorney General Ashley Moody received your email regarding your concerns with the handling of your friend's criminal case by the Office of Ninth Judicial Circuit State Attorney Aramis Ayala.

I attempted to reach you by phone; unfortunately, your voice mail was not accepting messages. I hope the following information proves helpful.

The prosecution of potential violations of criminal law is under the jurisdiction of the elected state attorney in each judicial circuit. The state attorneys operate independently and are not a part of the Attorney General's Office. Therefore, I encourage you to express your concerns directly to State Attorney Ayala. If you would like, I am happy to forward your correspondence to that office for review. Additionally, crime victims may also be eligible for financial assistance for medical care, mental health services, and other out-of-pocket expenses directly related to the injury. 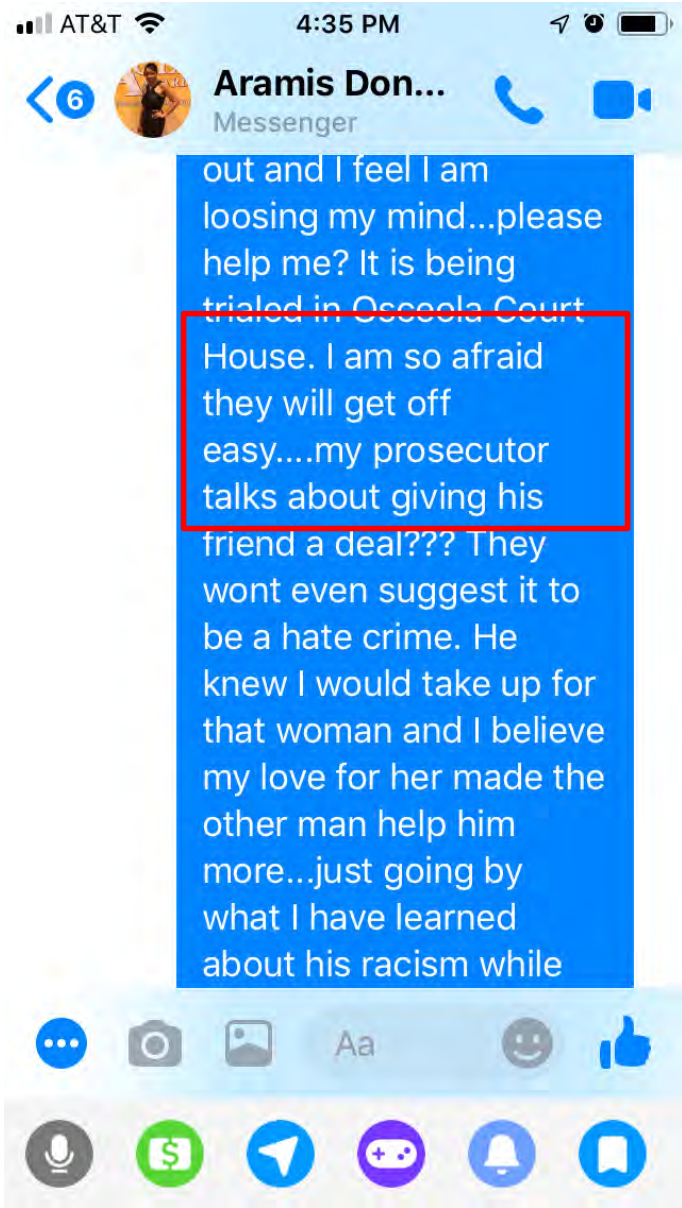
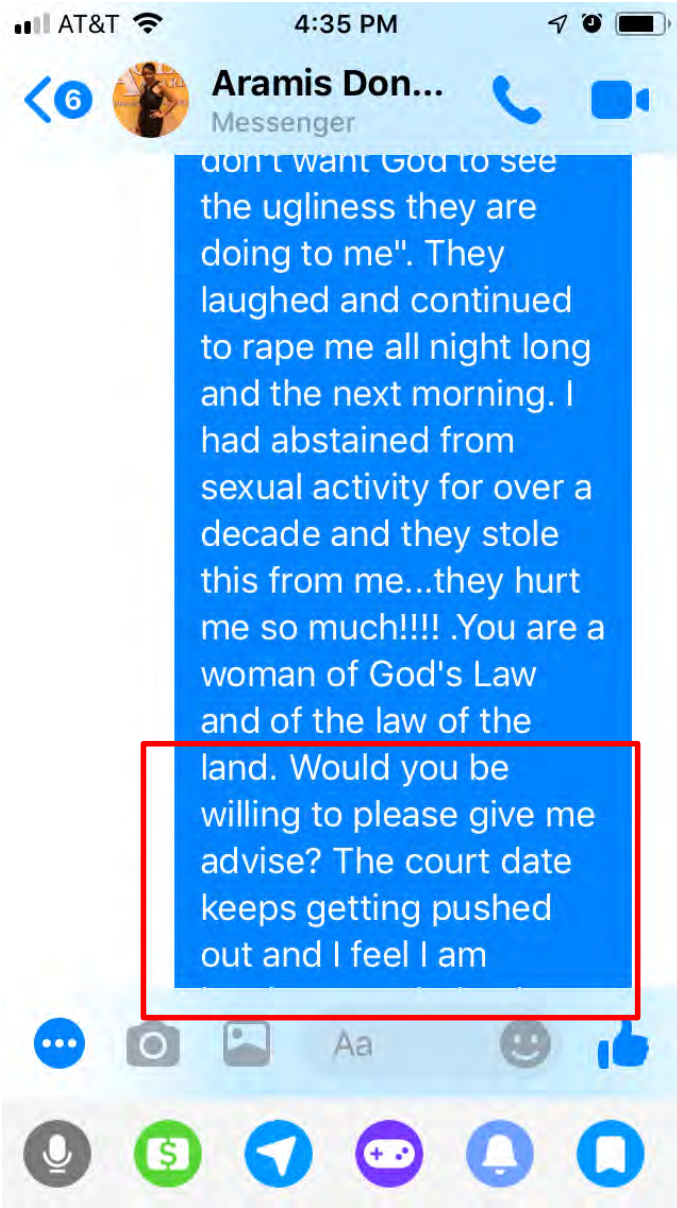
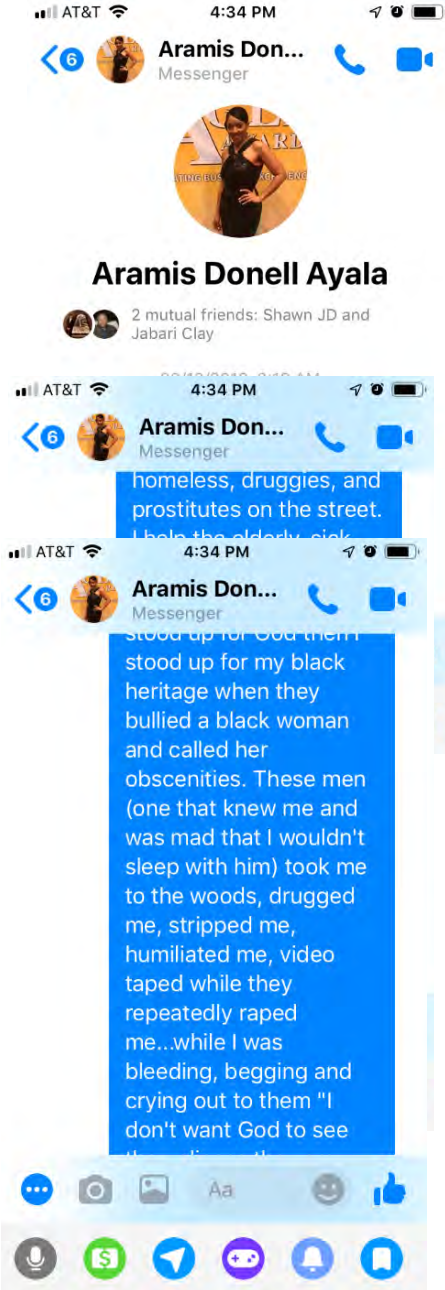
Dear State Attorney, Aramis Alaya,

My name is Janet Kotz. 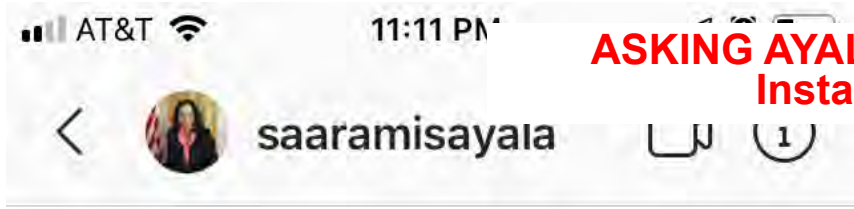

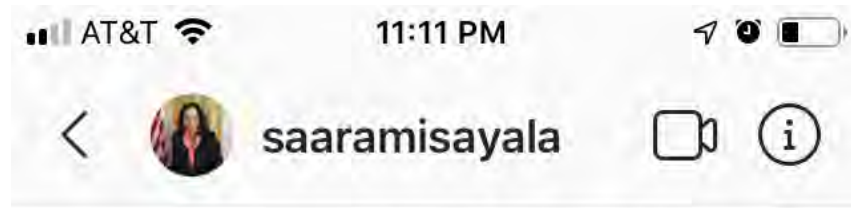

The only thing that would totally discredit you to me is if I find out you allowed this frivolous plea deal to happen because the defense Feiter Law is a 13 year friend with Deb Bara and supporting her campaign.

Sorry but since my rapist just got out of jail and spent less time in there than I spent bleeding from what they did to me I'm a little upset tonight. I'm not threatening. I'm a Sunday school teacher that came from New Warner Chapel in Winter Park and friends with the late founder Mitchell L Dawkins senior's family. We aren't the scary people- the ones that got out are. I'm sorry for so many messages but Instagram only allows so many words before it cuts off.
