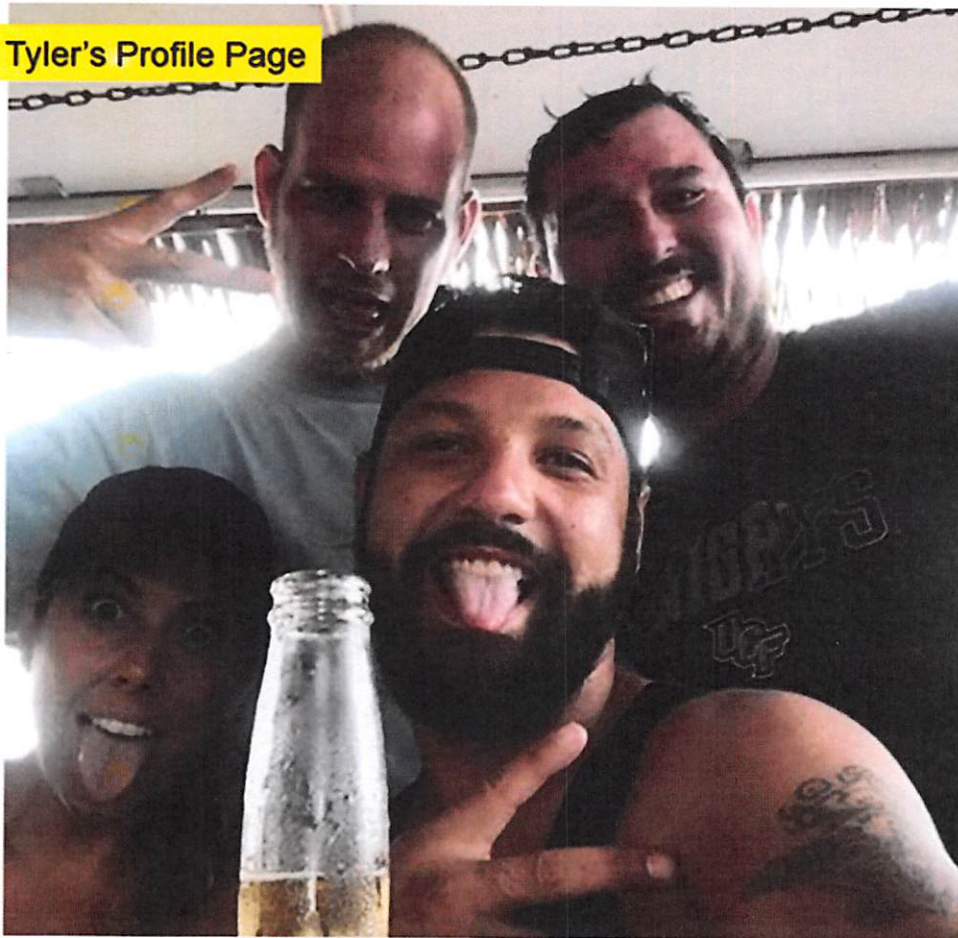

I have copied Maria Nunez on this email to introduce you to a **real** "Victims Advocate/Counselor", perhaps she could teach you something? My only true friend, I think? She may have been able to fool me like Suzanne did, so I could be wrong. I just don't know? I have also attached a brief, "if you want to know what not to do to a real victim of rape" sheet, in case you want to actually help someone in the future. Things like, telling a rape victim she shouldn't worry about sending out her nude photos because she has a great body, or a deputy asking a real rape victim if she has a picture of her vagina for him after he's been giggling and mocking her during her statement, one good thing you did though; like telling a rape victim she should be happy with a battery charge over the phone is a

great idea, Sean. Tell a rape victim to her face that your counter offer of just battery with time is a good one, and you might really get a felony battery charge on someone....I hope the sheet will help someone down the road. Who knows? I'm including a link to the Florida Statute for you guys to read up on the rights a victim has, since you seem to only be concerned about the rights of the criminals. We have rights too!

Now knowing that a victim is to remain blind, deaf, and dumb, I already know that I can't even participate in the plea bargaining; I can accept the fact right now that it will not go my way. I have already accepted that you will do whatever you want to do to just check the box...you got a conviction. Great for your record. Felony Battery, thinking that would be okay? You DO NOT belong in sex crimes Sean

All these years of teaching street gangs they can be friends with the police, all these years of speeches against domestic violence, all the under privileged kids I taught karate to in the police athletic league gym, all the black kids in my ministry I've taught to trust the system, all of it a bunch of crap! All of you can go home after your 8 to 5 jobs and just count me as the one that slipped between the cracks. These men killed my soul, all of you buried it. If these men don't get Sexual Battery and be put on the Sex Offenders list; you are right Suzanne, I will be the strongest advocate you have ever met. I will publicly advocate rape victims to **NOT TURN IN THEIR RAPIST** in District 9 unless they want to be humiliated even more. I still have five days left to get it out there during, "Sexual Assault Awareness Month". After April I'm certain no one will care, but there is always next year.

By the way, do I need a lawyer to get a copy of all the evidence, or are you really going to give it to me like you said you would? You know, the 6 photo DVDs, the photos sent to the PA, the statements from their so-called witnesses...yeah, let's see if you actually will give that to me.

This is probably good-bye to all of you. (No, I won't kill myself Suzanne, all of you and the rapist did that for me, so don't threaten me with a baker act if you don't want to steal what is left of my money from the handicap children and sick and old people I support). I am saying good-bye, because I never want to see any of you ever again.

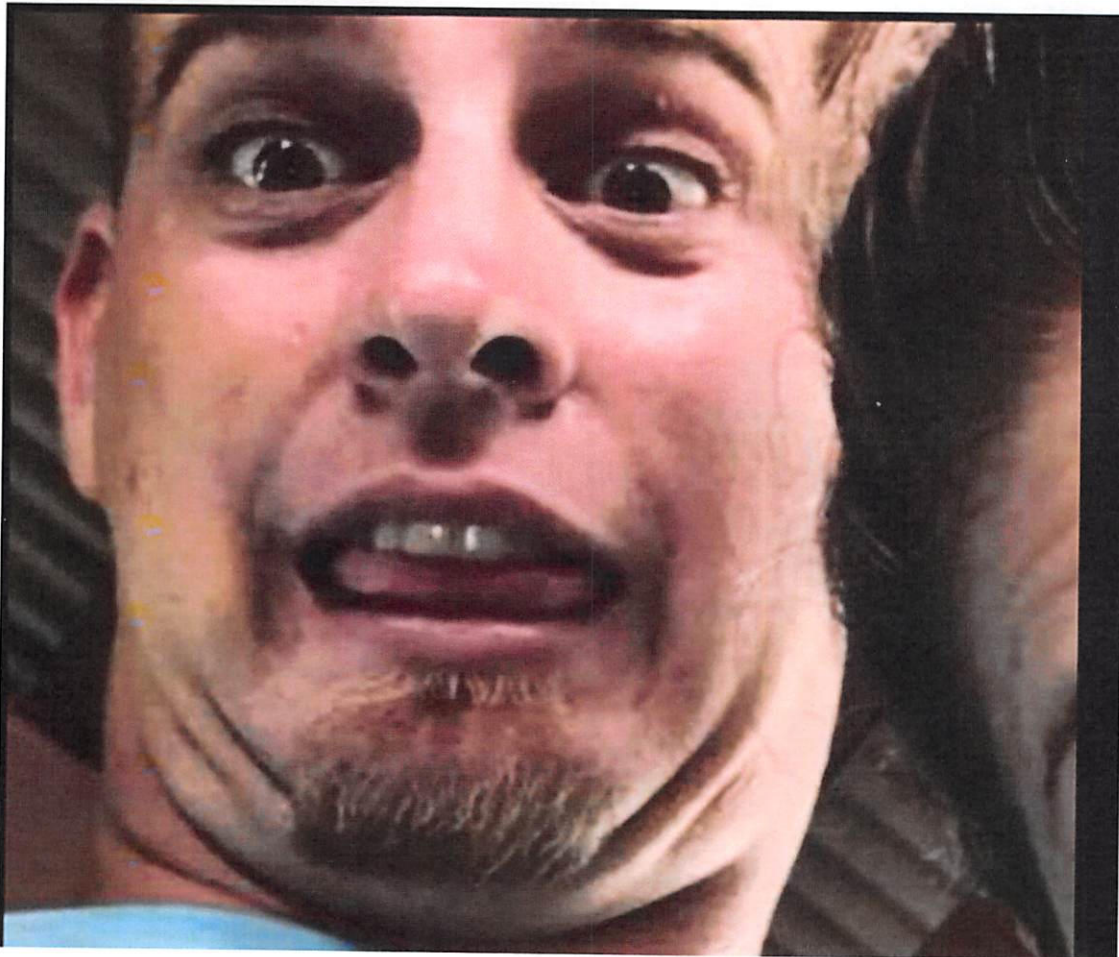
